

# Technical Meeting of the International Working Forum on Regulatory Supervision of Legacy Sites on Safety Assessment and Environmental Impact Assessment in Remediation

6 - 10 January 2025

#### **Information Sheet**

#### Introduction

The IAEA's International Working Forum on Regulatory Supervision of Legacy Sites (RSLS) focusses on efforts to better regulate existing sites and facilities and to avoid the creation of new legacy sites. The activities implemented through RSLS promote effective and efficient regulatory supervision and remediation of legacy sites, consistent with the IAEA Fundamental Principles, Safety Standards and proven international practices.

## **Objectives**

The objectives of this meeting are to share experiences and lessons from Member States who have adopted and implemented strategies and solutions in Management of areas affected by past activities or events in Member States, to present the progress on the development of the new IAEA Safety Guide DS538 – Long Term Post-Remediation Management of Areas Affected by Past Activities or Events, and to establish the RSLS workplan for the next phase 2025-2028.

### **Target Audience**

Representatives of decision makers, regulatory bodies, technical support organizations, implementers and other interested parties of Member States, involved in remediation and post-remediation management.

## Working Language(s)

English

### **Participation and Registration**

All persons wishing to participate in the event have to be designated by an IAEA Member State or should be members of organizations that have been invited to attend.

In order to be designated by an IAEA Member State or invited organization, participants are requested to submit their application via the InTouch+ platform (<a href="https://intouchplus.iaea.org">https://intouchplus.iaea.org</a>) to the competent national authority (Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) or organization for onward transmission to the IAEA by 1 October 2024, following the registration procedure in InTouch+:

1. Access the InTouch+ platform (<a href="https://intouchplus.iaea.org">https://intouchplus.iaea.org</a>):

Persons with an existing NUCLEUS account can sign in to the platform with their username and password;

Persons without an existing NUCLEUS account can register here.

2. Once signed in, prospective participants can use the InTouch+ platform to:

Complete or update their personal details under 'Complete Profile' and upload the relevant supporting documents;

Search for the relevant event under the 'My Eligible Events' tab;

Select the Member State or invited organization they want to represent from the drop-down menu entitled 'Designating Authority' (if an invited organization is not listed, please contact <a href="InTouchPlus.Contact-Point@iaea.org">InTouchPlus.Contact-Point@iaea.org</a>);

If applicable, indicate whether financial support is requested and complete the relevant information (this is not applicable to participants from invited organizations);

Based on the data input, the InTouch+ platform will automatically generate the Participation Form (Form A) and/or the Grant Application Form (Form C);

Submit their application.

Once submitted through the InTouch+ platform, the application, together with the auto-generated form(s), will be transmitted automatically to the required authority for approval. If approved, the application, together with the applicable form(s), will automatically be sent to the IAEA through the online platform.

NOTE: The application for financial support should be made, together with the submission of the application, by 1 October 2024.

Selected participants will be informed in due course on the procedures to be followed with regard to administrative and financial matters.

## **Expenditures and Grants**

No registration fee is charged to participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to normally one participant per country, provided that, in the IAEA's view, the participant will make an important contribution to the event.

The application for financial support should be made, together with the submission of the application, by 1 October 2024.

#### Venue

The event will be held at the Vienna International Centre (VIC) where the IAEA's Headquarters are located. Participants must make their own travel and accommodation arrangements.

Participants are advised to arrive at Checkpoint 1/Gate 1 of the VIC one hour before the start of the event on the first day in order to allow for timely registration. Participants will need to present an official photo identification document in order to be admitted to the VIC premises.

#### Visas

Participants who require a visa to enter Austria should submit the necessary application to the nearest diplomatic or consular representative of Austria at least four weeks before they travel to Austria. Since Austria is a Schengen State, persons requiring a visa will have to apply for a Schengen visa. In States where Austria has no diplomatic mission, visas can be obtained from the consular authority of a Schengen Partner State representing Austria in the country in question.
