Introduction

The Convention on the Physical Protection of Nuclear Material (CPPNM) entered into force on 8 February 1987, and the Amendment entered into force on 8 May 2016. The CPPNM and its Amendment, the only legally binding undertakings in the area of physical protection of nuclear material and of nuclear facilities used for peaceful purposes, underpin nuclear security around the world. The Amendment expands the scope of application of the original Convention to cover the physical protection of nuclear material in domestic use, storage and transport, and of nuclear facilities used for peaceful purposes. It also provides for expanded cooperation between and among States, inter alia, with regard to implementing rapid measures to locate and recover missing or stolen nuclear material, as well as mitigating or minimizing any radiological consequences of sabotage of nuclear material or nuclear facilities. It further expands on the list of offences involving or directed at nuclear material or nuclear facilities that must be criminalized by States Parties. These instruments are pertinent for all States, not just those with nuclear facilities or material. Universal adherence to and full implementation of the CPPNM and its Amendment will help to ensure that nuclear material and facilities throughout the world are properly protected against malicious acts.

Objectives

The objective of the meeting is to promote further adherence to, and effective implementation of, the CPPNM and its Amendment through facilitating bilateral cooperation and assistance among States, and to enable discussions on practical experiences and lessons learned in adherence to, and implementation

of, the CPPNM and its Amendment.

Target Audience

The workshop is open to all countries that have not joined the CPPNM and its Amendment. Designated participants should be officials of national governments with responsibility for facilitating the adherence to the CPPNM and the Amendment. Preference will be given to officially designated legal and/or technical officials from national authorities that are responsible for adherence to the CPPNM and its Amendment.

Introduction

The Convention on the Physical Protection of Nuclear Material (CPPNM) was adopted in 1979 and entered into force in 1987. On 8 July 2005, States Parties to the Convention adopted, by consensus, an Amendment to the Convention in order to broaden its scope, which entered into force on 8 May 2016. The Convention and its Amendment are the only international legally binding undertakings in the area of physical protection of nuclear material and of nuclear facilities used for peaceful purposes.

Objectives

The objective of the meeting is to discuss matters within the scope of the CPPNM and the Amendment thereto with particular emphasis on improving mechanisms for information sharing and promoting universalization of the Amendment through adherence to it by States that are not yet party to it.

Target Audience

Parties to the CPPNM and the Amendment thereto are invited to designate one or more participants for this meeting. Participants should represent their State Party's Point of Contact, or be senior officials of governments with responsibility for the implementation of the CPPNM and the Amendment thereto. States Parties to the CPPNM and its Amendment also are encouraged to nominate representatives to participate in the Technical Meeting to Promote the Universalization of the CPPNM and its Amendment to be held from 21-22 November 2024.
