Introduction

The Small Modular Reactor (SMR) Regulators' Forum is a regulator-to-regulator group. Its Terms of Reference states that the purpose of this Forum is to identify, enhance understanding of and address key regulatory challenges that may emerge in SMR regulatory discussions. This will help enhance safety and efficiency in SMR regulation, including licensing, and enable regulatory bodies to inform changes, if necessary, to their requirements and regulatory practices. The IAEA is functioning as the Scientific Secretary to promote and facilitate the Forum's activities. In 2019, the Steering Committee of the SMR Regulators' Forum decided to disseminate the identified regulatory challenges related to SMRs and its common positions to embarking countries through educational workshops.

SMRs offer a viable alternative to larger nuclear power reactors due to their smaller size and potential inherent safety characteristics. In terms of political and financial commitments required, SMRs can be built in larger numbers, more quickly and in remote locations throughout the world. For these reasons, SMRs might represent a more attractive option to both embarking countries and countries expanding their existing nuclear power programmes. These countries have varying capabilities — ranging from no nuclear experience to experience with laboratory scale nuclear facilities and industrial applications, the operation of research reactors or the handling of radioactive material in large amounts. In this context, they may struggle with the licensing of SMRs due to uncertainties regarding applicable safety requirements, which, at present, focus mainly on the reactor designs commercially deployed. National

safety requirements need to consider the specific features of SMRs and the application of a graded approach to existing safety requirements. According to the IAEA Safety Standards, from the earliest phase of the development of safety infrastructure, the prime responsibility for safety rests with the prospective facility operating organization. The government, on the other hand, is required to establish an effective governmental, legal and regulatory framework to support a high level of safety.

As design and deployment activities related to SMRs around the world are progressing, the workshop will provide insights into the discussions held during the SMR Regulators' Forum meetings over the last three phases of its work. Regulatory bodies' staff participating in the workshop will benefit from the exposure to the common positions developed by the Forum's working groups, thus clarifying regulatory views regarding SMR safety demonstration proposals and regulatory practices that may need to be reevaluated. The workshop programme will be supplemented by presentations on the current SMR technologies and country-specific presentations by invited expert members of the SMR Regulators' Forum and will provide an ample opportunity for information and experience exchange between the lecturers and the participants, as well as among the participants themselves.

Objectives

The purpose of the workshop is to share the challenges associated with regulation of small modular reactors (SMRs) and approaches to overcoming them, including possible changes to regulatory requirements and practices based on the common positions developed by the SMR Regulators' Forum.

Target Audience

This workshop is intended for the regulatory bodies of countries embarking on a nuclear power programme or countries considering expanding their nuclear power programmes and considering the deployment of SMRs in the medium term.

Topics

The following topics will be covered during the workshop:

- Introduction to the SMR Regulators' Forum, its activities and outputs;
- Applicability of the IAEA Safety Standards to SMRs;
- Overview of SMR technologies;
- The IAEA initiatives on SMRs, including NHSI collaborative work;
- Application of Defence-in-Depth and Graded Approach to SMRs;
- Emergency Planning Zone for SMRs;
- Licensing process challenges related to SMRs:
 - Key regulatory interventions;
 - First-of-a-Kind (FOAK) vs Nth-of-a-Kind (NOAK) designs;
 - Licensing of multiple module/unit facilities; and

- Process for leveraging other regulatory bodies' reviews and for cooperative reviews.
- Design and Safety Analysis for SMRs:
 - Multi-unit, multi-module aspects of SMRs;
 - Considerations in the use of passive and inherent safety features in SMR designs;
 - Aspects of beyond design basis analysis relevant to SMRs;
 - Integrated approach among Safety, Security and Safeguards (the 3S); and
 - Consideration of confinement/ containment systems for non-water cooled SMRs.
- Manufacturing, construction, commissioning, operations issues:
 - Manufacturability, supply chain management and commissioning of SMRs;
 - Collection and Use of Experience in the Lifecycle of Small Modular Reactor facilities;
 - Conduct of Maintenance in an SMR:
 - Conduct of Co-activities and Combined Activities on a Multiple Unit SMR Facility Site;
 - Regulatory Considerations in Pre-Licensing Engagement for Long-Lead Requests and Items (LLI); and
 - Conduct of Authorized Activities: Impact on Stakeholders' Organizational Capabilities (Designers, Vendors, Manufacturers, Supply Chains, Operators).

A half-day visit to a nuclear facility will also be organized.

Participation and Registration

All persons wishing to participate in the event have to be designated by an IAEA Member State or should be members of organizations that have been invited to attend.
