The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the IAEA's Member States and has the honour to draw their attention to the **Regional Workshop on the Convention on Supplementary Compensation for Nuclear Damage (CSC)** (hereinafter referred to as "event") to be held in Vilnius, Lithuania, from 10 to 13 December 2024.

The purpose of the event is to provide information on the CSC, its role in establishing a global nuclear liability regime as called for by the IAEA General Conference and its relevance and benefits to the Member States proposed to be invited to the event. The event will address the needs of decision-makers, policy-makers and senior officials (from Member States with and without nuclear installations), as well as other officials including those engaged in the regulation and implementation of nuclear activities. Moreover, the event will provide a comprehensive high-level overview of the considerations underlying the field of civil liability for nuclear damage, the CSC, the Global Nuclear Liability Regime and the other international nuclear liability instruments adopted under the auspices of the IAEA.

The attached Information Sheet provides further details of the event.

The event will be held in English.

Member States are invited to designate one or more participants for this event. Member States are strongly encouraged to identify women participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to up to two participants per country, provided that, in the IAEA's view, the participant will make an important contribution to the event.

The application for financial support should be made via the InTouch+ platform not later than 11 November 2024, as indicated in the enclosed Information Sheet.

It should be noted that compensation is not payable by the IAEA for any damage to or loss of personal property. The IAEA also does not provide health insurance coverage for participants in IAEA events. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.

Designations should be submitted to the IAEA via the InTouch+ platform (<a href="https://intouchplus.iaea.org">https://intouchplus.iaea.org</a>) through the competent national authority (Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) not later than 11 November 2024, as indicated in the enclosed Information Sheet.

The Administrative Secretary of the event will liaise with the participants directly concerning further arrangements, including travel details, as appropriate, once the official designations have been received.

The Secretariat of the International Atomic Energy Agency avails itself of this opportunity to renew to the IAEA's Member States the assurances of its highest consideration.
