Introduction

The purpose of this International Atomic Energy Agency (IAEA) event is to assist Member States in developing national operational arrangements that are consistent with the Operations Manual for Incident and Emergency Communication, to strengthen and foster the harmonization of national arrangements for response to radiological and nuclear emergencies, and to further enhance Member States' compliance with international standards as laid down in Preparedness and Response for a Nuclear or Radiological Emergency (IAEA Safety Standards Series No. GSR Part 7, Vienna, 2015). This includes support for Member States in establishing and maintaining up-to-date knowledge and competence with regard to notification, reporting and requesting assistance in accordance with the relevant IAEA standards and guidance. The event is designed to contribute to the development of capabilities in this area. Counterparts from Member States will also improve their awareness and understanding of the International Radiation Monitoring Information System (IRMIS) including training on roles, features and information sharing arrangements for monitoring data.

Objectives

The main objective of the event is for the participants (i.e. representatives of official Contact Points) to achieve an increased level of knowledge and ability to use the IAEA's arrangements and resources for international notification, reporting and requesting assistance during an emergency and administrative arrangements and tools provided by IRMIS, demonstrated through subsequent participation in the IAEA's regular international emergency exercises (ConvEx). Participants are expected to be able to share the knowledge acquired with relevant staff in their organizations. The participants will become familiar with:

- The rights and responsibilities for notification and reporting under the Convention on Early Notification of a Nuclear Accident (the “Early Notification Convention”);
- The rights and responsibilities under the Convention on Assistance in the Case of a Nuclear Accident or Radiological Emergency (the “Assistance Convention”);
- The functions that Member States should fulfil with regard to incident and emergency communications;
- The different communication mechanisms for information exchange on incidents and emergencies at the international level;
- The official communication forms used for notifying, reporting and requesting information or assistance;
- Use of the Unified System for Information Exchange in Incidents and Emergencies (USIE) website for reporting incidents and emergencies;
- Use of the International Radiation Monitoring Information System (IRMIS) website to share and visualize large quantities of routine and emergency radiation monitoring data;
- Basic IT hardware and software requirements that IRMIS Data Providers must meet for the collection and dissemination of radiation monitoring data
- The Practical Arrangements for IRMIS and the technical responsibilities these entail for participating Member States
- How to prepare routine monitoring data according to the International Radiological Information Exchange (IRIX), version 1.0 format, for submission to IRMIS
- The overall applicability of IRMIS in routine and emergency modes, including all of its features and built-in tools; and
- The ConvEx emergency exercise regime and how to participate in, and learn from, such exercises.

Target Audience

The event is open to participants from the invited Member States and is intended for the established Contact Points under the Early Notification Convention or the Assistance Convention. Other official points of contact for liaison with the IAEA on related matters from Member States that are not yet party to these conventions can also participate in the event. The participants must demonstrate responsibilities and/or operational experience in emergency communications related to the above-mentioned conventions or be representatives from points of contact for IRMIS. Priority will be given to applicants from the Americas (South, Central, and North) to facilitate regional collaboration and proximity to the workshop host country, Brazil.

Working Language(s)

English

Participation and Registration

All persons wishing to participate in the event have to be designated by an IAEA Member State or should be members of organizations that have been invited to attend.

In order to be designated by an IAEA Member State or invited organization, participants are requested to submit their application via the InTouch+ platform (<https://intouchplus.iaea.org>) to the competent national authority (Ministry of Foreign Affairs, Permanent Mission to the IAEA or National Atomic Energy Authority) or organization for onward transmission to the IAEA by **16 February 2026**, following the registration procedure in InTouch+:

1. Access the InTouch+ platform (<https://intouchplus.iaea.org>):
 - Persons with an existing NUCLEUS account can sign in to the platform with their username and password;
 - Persons without an existing NUCLEUS account can register [here](#).
2. Once signed in, prospective participants can use the InTouch+ platform to:
 - Complete or update their personal details under ‘Complete Profile’ and upload the relevant supporting documents;
 - Search for the relevant event under the ‘My Eligible Events’ tab;
 - Select the Member State or invited organization they want to represent from the drop-down menu entitled ‘Designating Authority’ (if an invited organization is not listed, please contact InTouchPlus.Contact-Point@iaea.org);
 - If applicable, indicate whether a paper is being submitted and complete the relevant information;
 - If applicable, indicate whether financial support is requested and complete the relevant information (this is not applicable to participants from invited organizations);
 - Based on the data input, the InTouch+ platform will automatically generate the Participation Form (Form A) and/or the Grant Application Form (Form C);
 - Submit their application.

Once submitted through the InTouch+ platform, the application, together with the auto-generated form(s), will be transmitted automatically to the required authority for approval. If approved, the application, together with the applicable form(s), will automatically be sent to the IAEA through the online platform.

NOTE: The application for financial support should be made, together with the submission of the application, by **16 February 2026**.

Expenditures and Grants

No registration fee is charged to participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the event. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Upon specific request, such assistance may be offered to normally one participant per country, provided that, in the IAEA's view, the participant will make an important contribution to the event.
