Information Sheet

Purpose

The purpose of the event is to discuss and share experiences on strengthening capabilities in Integrated Risk-Informed Decision-Making (IRIDM) through the application of Probabilistic Safety Assessment (PSA) and the exchange of best practices relevant to mid-level managers.

Working Language(s)

The working language(s) of the event will be English.

Deadline for Nominations

Nominations received after 28 November 2025 will not be considered.

Project Background

The project is designed to assist Member States (MSs) in the Europe and Central Asia region in building capacities in severe accident management and analyses of off-site consequences, which is critical in terms of protecting people and environment against the harmful effects of ionizing radiation.

The project is directly related to nuclear technology and is devoted to the topic of severe accidents at nuclear installations and potential releases.

The project will foster the implementation of the recommendations stated in relevant IAEA Safety Standards (e.g. Specific Safety Guides (SSG)-54, SSG-3 and 4) on use of risk information for the purposes of severe accident management.

Scope and Nature

The overall objective of the regional workshop is to address the wide range of PSA applications, covering both regulatory and utility implications with specific focus on the needs and challenges of midlevel managers. It is planned to discuss the current practices and challenges in the area of Integrated Risk Informed Decision Making addressing the synergy between various inputs to decision making (e.g. such as risk insights, deterministic considerations, operating experience, human and organisational factors, regulatory framework implications).

The workshop will consist of presentations given by IAEA staff and invited experts, as well as national presentations provided by workshop participants.

In addition, it is planned to organize a working session aimed to discuss the specific factors affecting concrete risk-informed decisions and gain practical experience on that.

National presentations and technical discussions on available national experiences and current challenges in the topical area of the event are specifically encouraged.

Participation

The workshop is open to up to 25 participants from TCEU Member States participating in the regional TC project RER9160.

Participants' Qualifications and Experience

The nominees for the regional workshop should be representatives of regulatory bodies, operating organizations, design organizations, technical support organizations, research or governmental institutes and industry, actively involved in the decision-making process. The participants should have several years of experience and should have a background in use of safety assessment inputs for decision making and/or PSA, PSA applications and/or integrated Risk Informed Decision Making.

Participants of the workshop will be requested to make a presentation on their national experience and approaches used in the event subject areas.

Application Procedure

Candidates wishing to apply for this event should follow the steps below:

- 1. Access the InTouch+ home page (https://intouchplus.iaea.org) using the candidate's existing Nucleus username and password. If the candidate is not a registered Nucleus user, she/he must create a Nucleus account (https://websso.iaea.org/IM/UserRegistrationPage.aspx) before proceeding with the event application process below.
- 2. On the InTouch + platform, the candidate must:
 - a. Finalize or update her/his personal details, provide sufficient information to establish the required qualifications regarding education, language skills and work experience ('Profile' tab) and upload relevant supporting documents;
 - b. Download and complete the <u>Designation of Beneficiary and Emergency Contact Form</u>, and upload to InTouch+ ('Profile' tab under the personal section) specifying the document name. If already provided, kindly discard this step; and
 - c. Search for the relevant technical cooperation event (EVT2501301) under the 'My Eligible Events' tab, answer the mandatory questions and lastly submit the application to the required authority.

NOTE: Completed applications need to be approved by the relevant national authority, i.e. the National Liaison Office, and submitted to the IAEA through the established official channels by the provided designation deadline.

Should online application submission not be possible, candidates may download the nomination form for the meeting from the IAEA website.

NOTE: A medical certificate signed by a registered medical practitioner dated not more than four months prior to starting date of the event must be submitted by candidates when applying for a) events with a duration exceeding one month, and/or b) all candidates over the age of 65 regardless of the event duration.

Administrative and Financial Arrangements

Nominating authorities will be informed in due course of the names of the candidates who have been selected and will at that time be informed of the procedure to be followed with regard to administrative and financial matters.

Selected participants will receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses. They will also receive either a round-trip air ticket based on the most direct and economical route between the airport nearest their residence and the airport nearest the duty station through the IAEA's travel agency AX Travel Management, or a travel allowance, or they will be reimbursed travel by car/bus/train in accordance with IAEA rules for non-staff travel.

Disclaimer of Liability

The organizers of the event do not accept liability for the payment of any cost or compensation that may arise from damage to or loss of personal property, or from illness, injury, disability or death of a participant while he/she is travelling to and from or attending the course, and it is clearly understood that each Government, in approving his/her participation, undertakes responsibility for such coverage. Governments would be well advised to take out insurance against these risks.

Note for female participants

Any woman engaged by the IAEA for work or training should notify the IAEA on becoming aware that she is pregnant.

The Board of Governors of the IAEA approved new International Basic Safety Standards for Protection against Ionizing Radiation and for the Safety of Radiation Sources. The Standards deal specifically with the occupational exposure conditions of female workers by requiring, inter alia, that a female worker should, on becoming aware that she is pregnant, notify her employer in order that her working conditions may be modified, if necessary. This notification shall not be considered a reason to exclude her from work; however, her working conditions, with respect to occupational exposure shall be adapted with a view to ensuring that her embryo or foetus be afforded the same broad level of protection as required for members of the public.
